Subject: Preparing an General Plan Amendment to Designate Infill Nonresidential
Parcels under UKIALUCP §3.3.5

Summary

Staff is preparing an application, pursuant to Section 3.3.5 of the Ukiah Valley Airport Land Use Compatibility Plan (UKIALUCP), to identify specific parcels within city limits as eligible for infill nonresidential development. This action advances the City's long-term land use goals while maintaining consistency with airport compatibility standards, policies and expectations.

Background

Policy 3.3.5 allows the Airport Land Use Commission (ALUC) to consider infill development in areas where existing land uses do not meet current compatibility criteria, if certain conditions are satisfied and the eligible lands are mapped. The City intends to seek ALUC approval of an infill designation for selected parcels primarily within Compatibility Zones 2, 3, and 4 north, east, and west of Ukiah Municipal Airport.

Proposed Infill Areas and Findings

Staff evaluated candidate sites (see Exhibit A: Map and Parcel Inventory) and finds they meet the UKIALUCP infill criteria:

- The parcels lie within cohesive areas where generally $\geq 65\%$ of existing uses were established prior to the UKIALUCP's adoption and are nonconforming with current compatibility policies.
- Each parcel:
 - Is already served by streets, water, sewer, and other infrastructure;
 - Has $\geq 65\%$ of its perimeter (excluding roadways) bounded by existing uses that are similar to or more intensive than the proposed use;
 - Is 20 acres or less in size;
 - Does not extend the perimeter of surrounding incompatible development;

- Has no prior open land designation under Policy 3.5.6 (or provides equivalent replacement open land within the same compatibility zone); and
- Is zoned consistently with surrounding, already-developed properties.

This request follows the UKIALUCP's preference that eligible infill parcels be identified collectively through a City-adopted planning document and reviewed by the ALUC. The City will submit a UKIALUCP insert, detailed maps, a parcel inventory, and supporting documentation demonstrating compliance to the ALUC and other bodies as required.

What an Infill Designation Allows

For qualifying nonresidential Infill locations, the average usage intensity (people per acre) of the proposed use may not exceed the lesser of:

1. Median Nearby Intensity: The median intensity of all existing nonresidential uses located fully or partially within 300 feet of the defined Infill area boundary; or
2. Two Times the Zone Average: $2 \times$ the average sitewide intensity permitted for that location per Table 3A.

In addition, the single-acre intensity limits in Table 3A apply to Infill development; and development cannot exceed the single-acre cap even if the overall sitewide average complies.

Illustrative Example:

As conveyed, in the UKIALUCP, if Table 3A permits an average of 100 people/acre and the median intensity of nearby nonresidential uses is 150 people/acre, the allowable intensity for the Infill project is 150 people/acre (the lesser of 150 and 200).

Optional Policy Discussion (for Commission Feedback)

Staff suggests considering narrowly tailored allowances for certain uses currently prohibited but capable of meeting objective requirements for their respective compatibility zones as part of the general plan amendment to facilitate infill development. In particular, staff suggests that restaurants, retail, indoor recreation, assembly facilities, and potentially others be considered conditionally compatible on designated infill parcels, where safety and intensity thresholds are met.

Feedback is requested on whether to include this concept in the application package or as a parallel City policy initiative.

Site Identification Criteria (Applied by GIS Staff)

- Parcel alignment with the UKIALUCP objective standards;
- Located along public road frontage;
- Served by existing utilities;
- Not adjacent to airport-owned parcels or within Zone 1 / Zone 1* areas;
- Within commercial or manufacturing base zoning districts;

Next Steps & Timeline

- Fall/Winter 2025: Refine General Plan Amendment (GPA) framework and supporting maps.
- Winter 2026: Submit application to the Mendocino ALUC for a consistency determination under UKIALUCP §3.3.5.
- Spring 2026: Planning Commission hearings on GPA/Zoning Code amendments.
- Spring/Summer 2026: City Council introduction and adoption.

Approval of the infill designation will allow the City to proceed with a GPA and Zoning Code amendments to codify infill policies for nonresidential projects that support economic activity along State Street, Gobbi Street, and School Street, without compromising airport safety or compatibility. Staff would develop objective zoning standards to be incorporated into Ukiah City Code.

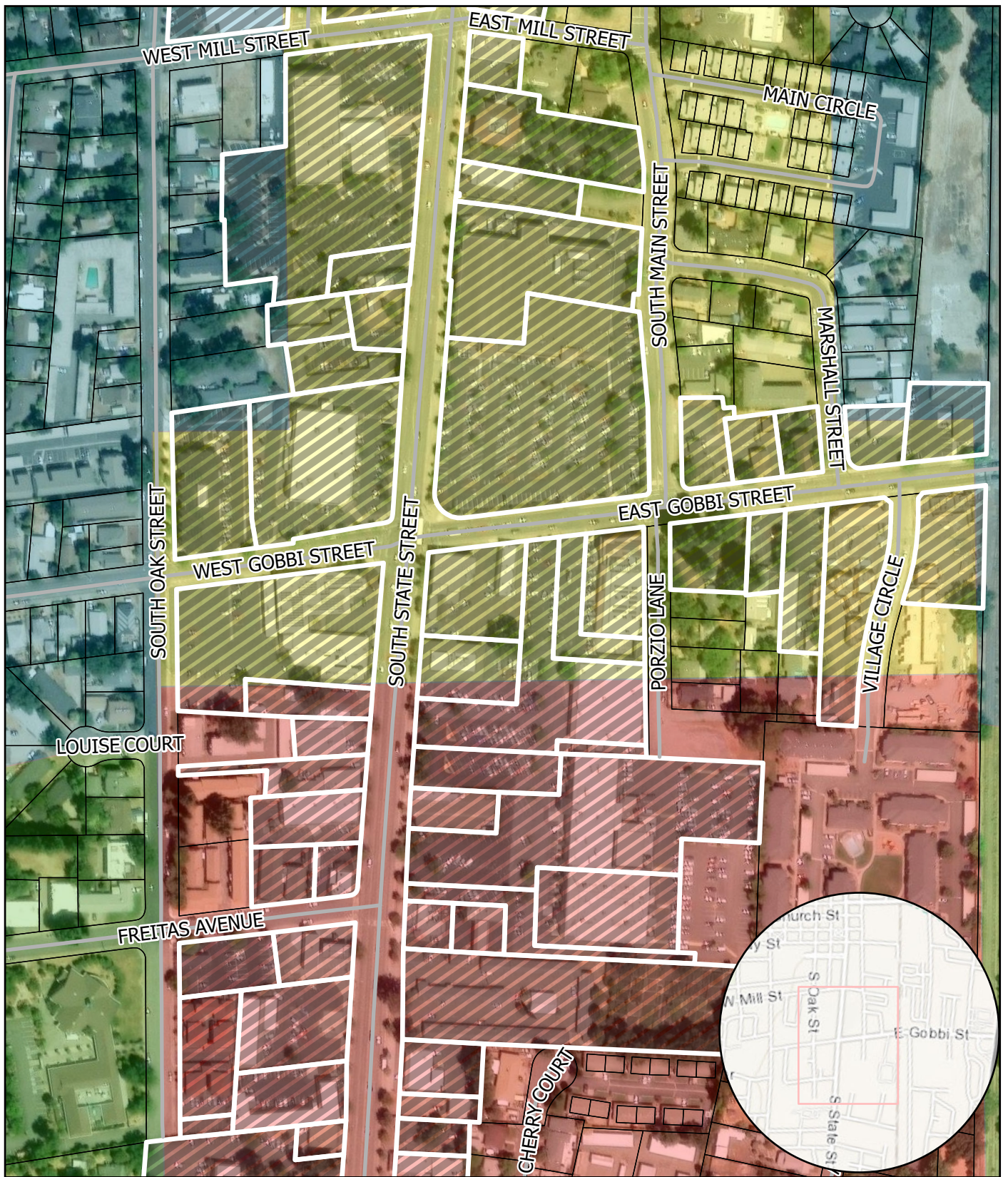
